## A New Partnership, a New Opportunity

SCAN has partnered with St. James's Children's Center to launch a pilot therapeutic preschool program. Three years ago, Executive Director Jeanine Harper and Mental Health Program Coordinator Lisa Wright began extensively researching the resources and skills needed to open a therapeutic program for at-risk preschool-aged children after identifying a need in the community. With help from our friends at Leadership Metro Richmond and our Therapeutic Preschool Task Group, SCAN made the decision to move forward with plans to help Richmond's at-risk preschool-aged children.

Based on best practices found through research and site visits, SCAN will prepare children who have social and emotional challenges for longterm educational success before they enter kindergarten. The program will help young children already involved in SCAN's programs, especially in our Child Advocacy Center, who have experienced trauma through abuse or neglect. The therapeutic program will also help children who are at-risk or have already been expelled from preschool due to behavioral issues stemming from abuse and neglect or other forms of trauma that prevent them from being successful in a school environment.



This program is possible through SCAN's partnership with St. James's Children's Center. The Children's Center is a culturally and academically diverse preschool that provides a nurturing environment for all children, including at-risk and special needs children. The Children's Center has been identified as a model for the Virginia Preschool Initiative.

The Children's Center will offer SCAN classroom space where our professionals will engage children 9 a.m. to 6 p.m. in high-quality early childhood education coupled with appropriate mental health services. We will involve the parents in all treatment, knowing from our other programs that by engaging parents we can truly set children up for future success. The therapeutic preschool will open February 1. We will keep you updated on our progress, our partners in the community and our new staff!

## How Do We Know We Make a Difference?

Through our Family Support Program, SCAN served 384 parents and 181 children during the 2009-2010 fiscal year. We currently offer 14 weekly psycho-educational groups for parents who have abused or are at risk of abusing their children.

Our work with parents is based on best practices, which we are constantly staying abreast of through research and training. Along with exit surveys and observations by our master's-level facilitators, one of the most important measures we use to gauge our success is the Adult-Adolescent Parenting Inventory, or AAPI.

Parenting Inventory, or AAPI.

The AAPI measures parents on their ability to set age-appropriate expectations for their children, their level of empathy, their beliefs in corporal punishment, their understanding of children's and parent's roles and their

concepts of their children's power and independence. Before they begin attending group sessions and after they have graduated, clients are given 40 statements about parenting in which they rate the statements in five different ways from "strongly agree," to "strongly disagree," to "uncertain."

Facilitators and parents are able to review the final scores of this nationally recognized test and evaluate problem areas parents have and in the end see how they've improved. By using this evidence-based approach, SCAN hopes to strategically change harmful family behavior and empower parents to protect their children. ## CASA Volunteer Tiffany Jana



Tiffany Jana is one of SCAN's 72 CASA (Court Appointed Special Advocate) volunteers. She graduated in October from the 35-hour training and observation program. Tiffany said she became a volunteer because of her own experience with her children in the court system.

"The whole thing can be so confusing for children," she said. "They can feel so disempowered. As soon as I found out about CASA I knew I wanted to join to make a difference."

Because she is trilingual, Tiffany is a valuable asset and improves SCAN's ability to serve Spanishspeaking clients. With experience speaking and translating both Spanish and German, Tiffany is helping SCAN reach Hispanic families in the Juvenile and Domestic Relations Court system. Her first case is a family with five children. Their home life is very complex and their support network consists of many different family members from different ethnicities and cultures. Tiffany said her upbringing in El Paso, Texas has helped her breach the communication and cultural gaps for the family of the children she

Like any CASA volunteer, she has gotten to know the family members, guidance counselors and teachers at the children's schools and the children themselves. With the expectation to visit with each child twice a month, Tiffany has dedicated a significant amount of hours to ensure she sees all five children. Her goal is to shorten the amount of time they spend in the court system and help them settle into safe and permanent homes. ## Lisa Wright, Mental Health **Program Coordinator**

When did you first come to SCAN? I began in November 2004 as the parttime mental health therapist for the CAC. My initial role was to set up the mental health program, which included purchasing supplies, setting up play therapy rooms, establishing curriculum for therapy and providing therapy for children who had experienced sexual and/or severe physical abuse. My position grew to full-time within a year then developed into a coordinator position as we added mental health staff.

#### What mental health services do we offer at the CAC?

We provide individual therapy for caregivers and children. Many caregivers have abuse history themselves and need additional support and guidance as they work through the abuse of their child. We provide joint and family sessions to help the family understand how to manage symptoms of the abuse and to assist with learning new and healthy coping strategies. In addition, we offer a weekly support group for all caregivers.

#### What is your average day like?

My days vary at the CAC, but usually include afternoon sessions with children, supervision of staff and clinical interns, completing documents for case files, meeting with caregivers of new clients and attending meetings for our work at the CAC.

I usually have between 20 to 25 clients on mv caseload.

#### talk Let's about our therapeutic preschool...

We are very excited to be opening a new Therapeutic Preschool for children ages 3 to 5 who have social and emotional difficulties. We are very excited to provide a therapeutic classroom that will include individual therapy for children and their caregivers, highly trained staff to assist with learning healthy relationship skills. We are looking forward to providing more support and intervention because we will have them for several hours every day. We will provide a nurturing and supportive environment for children and their caregivers - many of whom have never been nurtured or taken care of themselves and we want to show them how wonderful it feels. We will have the children for at least a full year and possibly two.

Our goal is to get them to the point where they can do well in kindergarten and/or return to a typical preschool. The environment at St. James's Children's Center is very warm and welcoming.

## **Board Member Mindy Meredith**

## When did you first get involved? Eight years ago, I went to the Pro-

gressive Dinner and I thought it was a lot of fun. I didn't really know a lot about the organization, and then I learned what SCAN was all about. I eventually got involved with recruiting hosts for the SCAN Progressive Dinner. I served on this committee for six years and chaired it two years. Last year I co-chaired the Progressive Dinner with Sasha Hogan.

#### Why do you stay involved?

I have an early childhood special education degree. I worked with social services, with the administration and created educational plans for the kids. I ended up leaving that field and got into high-tech sales, but missed it and SCAN was a really good fit for me. I was also impressed by Jeanine.

Also, when I was arowing up we used to have foster children. My mother was a single mother with three girls and she always ingrained in us to give and to help.

#### Why should others get involved with SCAN?

I think the big why is because there are so many innocent children who need our help. If we don't help them, then they won't get the help they need. When I taught, there was no SCAN or CAC or CASA. You all had to rely on the process of the government, and a lot of kids got lost. If you can get children while they are young, you can help them and their parents.

#### Forensic Interviewing at the Child Advocacy Center

At the Child Advocacy Center, our Multidisciplinary Teams consist of all service providers involved in cases of severe physical and sexual abuse, including law enforcement, child protective services, prosecution, mental health, medical services, and victim advocacy. Each are a part of a coordinated effort to help children and their parents recover from abuse and help prosecute their offenders. An integral part of success at the CAC lies in our forensic interviews.

Forensic interviewing is a first step at the CAC to find out if a child has been maltreated. The specialized interview process is designed to produce evidence that will stand up in court if a child's severe physical or sexual abuse leads to criminal prosecution. Successful forensic interviews are legally sound because the interviewers employ non-leading techniques and the CAC carefully documents the interviews. Recorded interviews can be used as evidence in court.

SCAN takes several measures to ensure the highest level of competency. SCAN trains MDT members, including several VCU Health System nurses and CAC staff members, to conduct forensic interviews. There is always someone available to perform this central part of our work at the CAC. Through peer reviews and offering other ongoing training, SCAN ensures our interviewers utilize the most current research and recommendations for child forensic interviews.

## **Protector's Circle Members Change Lives**

Our Protector's Circle members are a select group of individuals who support SCAN by making an annual gift of \$1,000 or more to our child abuse prevention and treatment services. During the annual event on Nov. 17 to celebrate their commitment to SCAN, members were able to hear first-hand stories from two CASA volunteers and two young women SCAN helped through our Family Support Program at New Life for Youth.

Last year SCAN began an important partnership with New Life to help the people who come to them in the worst circumstances. Many of the men and women face challenges such as drug and alcohol addiction. Through their faith-based program, New Life teaches these clients how to change their lives and after the year-long program New Life hopes clients can return to their families and gain meaningful employment.

SCAN works with the mothers and expectant mothers who live in the Women's Mercy House at New Life. Claudia Perez, Family Support Program facilitator, leads a 20-week nurturing parenting group for these mothers. We have graduated six mothers and will begin a new class in January. Many of the mothers in the group have lost custody of their children.

Leanne was one of these mothers. She came to New Life as an alternative to spending time in jail. She told Protector's Circle Members that she had been


battling a heroin addiction and been convicted of several misdemeanors, mostly related to stealing. Her child been had removed from her home by Child Protective Services.
