THE CACS SERVED 623 CHILDREN WHO WERE ALLEGED VICTIMS OF SEVERE PHYSICAL OR SEXUAL ABUSE (INCLUDING HUMAN TRAFFICKING, CHILD PORNOGRAPHY AND WITNESS TO VIOLENCE) AND 555 ADULTS INCLUDING THEIR NON-OFFENDING CAREGIVERS.
